## WELCOME !

Welcome to the **2017 iSail Lidgett Trophy**, proudly hosted by Davey's Bay Yacht Club ... an inspirational event for juniors offering on- & off-water coaching & racing (with on-water coaching) in four levels, being:

- Advanced: sailor is focussed on racing and can handle tougher weather conditions.
- Intermediate: sailor is comfortable in most conditions and is keen to improve general racing.
- Novice Blue: sailor can sail to windward comfortably & complete a course.
- Novice Green: sailor can sail, but may not yet be able to complete a true windward course.

*Note: Novices should have sailed previously. This is not 'learn-to-sail' course.*

## Boat Access, Delivery & Tide Times

**No 2WD on the beach** - please do NOT drive across beach to deliver boats in Two (2) wheel drives ... not only will you probably get bogged (sorry most do), but you will block the ONLY access to the club. There is a shuttle 'Kabota' that can tow trailers across if you do not have a 4WD.

Access for delivery of boats is via Davey's Bay Rd, turn right into Marathon Drive and then left through the stone gates into Brookwood Drive. Access to / tide times at Davey's Bay Yacht Club follow. Due to Frankston Pier tides, **entrants encouraged to deliver boats on Sun 12 & Fri 17 February** at times below:

- Sun 12 Feb 2017 b/n 0900 and 1800hrs, subject to tidal conditions (low @ 1125 hrs / high 1625 hrs).
- Fri 17 Feb 2017 b/n 1600 and 1900hrs, subject to tidal conditions (low @ 1425 hrs / high 2032 hrs).
- Sat 18 Feb 2017 from 0800hrs, subject to tidal conditions (high @ 0835 hrs / low @ 1511 hrs).
- Sun 19 Feb 2017 after presentation (low tide 1600 hrs)

*On Sunday, please don't bring cars onto beach until advised by DBYC (and only then after your child's boat is un-rigged).* Boats may be left at DBYC and picked up the next weekend by arrangement.

## Safety First

Safety is important for everyone. Competitors must be responsible for their own safety. All competitors must complete a Safety Self-Check and bring all necessary safety items to the event. Refer page headed 'Safety Self-Check'. Please also remember:

- Only leave the beach when your coaching level coloured flag (below) is raised on main club flag pole.
- DO NOT leave the beach if your level's coloured flag is NOT raised.
- Competitors must **sign-on & sign-off** every time you go on- & off- the water.
- Wear your coloured wrist band and display your **coloured streamer\*** on the end of your sprit (Optimists & Ozi-Opti) and end of your boom (Minnows & Sabots).

If your child has a **pre-existing medical condition or is injured during event**, please visit the DBYC Tower:

- During registration (Sat 8-10am) to advise medical condition, complete a 'Medical Form' and lodge the signed form with the event Safety Officer. This will help our medical team.
- As soon as possible in the case of an injury to ensure an 'Incident Report' form is completed.

## Sailor Registration

To complete your entry, all sailors must register which involves two steps:

1. Complete safety Self-Check (attached) & ask parents sign Entry Confirmation / Safety Self Check Form;
2. Take your signed Entry Confirmation / Safety Self-Check to registration in the junior club house; and
3. Attach your **coloured streamer** to sail (see above\*) & wear your coloured wrist band (*supplied at reg'n*).

## Power / Support Boat Drivers & Coaches (refer separate Briefing Document)

Thank you to clubs, classes & parents that have offered power boats – your support is appreciated.

Launching: Please launch and retrieve power boats at either Frankston or Mornington.

Registration: **Sat 8:15 - 9am**. Please register yourself (coach, drivers & boat), when you will receive:

- Boat or coach allocation and a unique boat # (for communication purposes).
- VHF radio – please use **Channel 72**, your boat # as ID, speak clearly & limit use.
- A grab bag of safety buoys for use in an on-water rescue situation where the DBYC Tower requests retrieval of children and not boats.
- Flag carrying the boat number for displaying as prominently as possible on the boat.
- Lunch, water & name tag.

Those coming on Sunday only, can register on Sunday 8:15 – 8:45am.

Briefing: **Sat 9:00am & Sun 8:30am** - All coaches and power boat drivers are asked to attend a briefing at the power boat / coach registration area.

Role: All power boats have a dual role – coaching (or race management) and safety / rescue when required. The safety role must take priority when called upon.

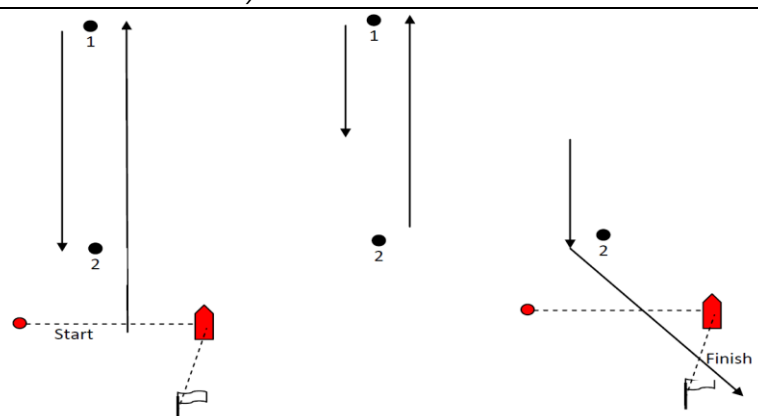
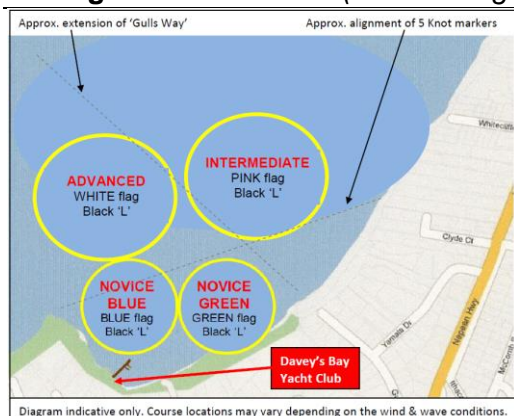

## A Smooth Start to the Event (Sat morning)

To ensure things run smoothly all parents and sailors are asked to follow the procedure outlined below. A team effort will make things easier for everyone. Remember – keep smiling!

### CLUB ACCESS & CAR PARKING

If not delivering a boat, please park cars at, and access the club from, the bottom of Davey's Bay Rd.

### PARENTS DELIVERING BOATS

- ❑ **no 2WD cars on the beach** (PLEASE)
- ❑ follow directions of marshals
- ❑ **drive slowly** at all times
- ❑ only carry passengers seated in 4WD

### SAILORS

1. unload boat & equipment.
2. **rig** boat on the beach (not on lawn), apply **duct tape** to back of boat & write your NAME(S) in large CAPITAL LETTERS.
3. complete safety self-check & ask parents sign Entry Confirmation / Safety Self Check Form.
4. take Entry Confirmation / Safety Self Check (attached) **signed by parent or guardian** to registration.
5. attach **streamer** to top of sail:
  - Advanced = White
  - Intermediate = Pink
  - Novice Blue = Blue
  - Novice Green = Green
6. if not done on-line and not sold out **pre-order** & pay for Saturday dinner.
7. attend **briefing**.
8. have fun, smile and learn lots !

1. **wait** at top of Elm Crt (Robs Way) until marshal calls you down, **OR**, to connect your trailer to club Kabota (if you don't have a 4WD)

2. **unload** boat & equipment immediately.

4. move empty **trailer** & store @ far Nth of yard. Please be sure to leave access way clear.

5. **REMOVE** car from beach / rigging area as soon as possible. Please drive back up Robs Way. Do **NOT** go up private access road.

6. park at bottom of **Davey's Bay Rd** (not in Elm Crt or Marathon Dve) – there is foot access along clifftop.

7. Assist sailors to prepare, including:
 

- Entry Confirmation / Safety Self-Check (requires signature)
- Register

8. if not done on-line or sold-out **pre-order** & pay for Saturday dinner

**REMEMBER:** A: **sign-on & sign-off** every time you go on- & off- the water.

B: Slip on a shirt, Slop on sunscreen, Slap on a hat

C: Listen to your coaches, keep smiling & enjoy!

## Conditions of Entry & Safety Self-check

**A completed form & signed Declaration must be lodged at registration for entry to be valid**

Before completing your entry / registration and receiving your entry streamer (to attach to the top of your sail) and coloured wrist band carrying your coaches name, all Applicants are required to:

1. Complete a safety self-check; and
2. Have a parent or guardian sign this Conditions of Entry & Safety Self Check declaration (*where indicated*).

### Safety & Safety Self-Check - Safety is a high priority

As an entrant and or parent / guardian please ensure entrants comply with all safety requirements, including those specified in class rules. In accordance with Conditions of Entry, Notice of Race and Sailing Instructions, entrants remain responsible for their own safety. Before registration is complete, each sailor is required to complete a safety self-check. The table below highlights important items for checking.

## Conditions of Entry (as per Notice of Race)

As the Applicant, I acknowledge and agree that:

In this Event application and declaration: "Club" means and includes Davey's Bay Yacht Club Inc. A0027135D ABN 17 245 667 668 of Davey's Bay, Mount Eliza, Victoria, 3930; Yachting Victoria Incorporated; the Victorian Sabot Sailing Association; the Victorian Minnow Association; the Victorian International Optimist Dinghy Association Inc; Royal Brighton Yacht Club; Mornington Yacht Club; other assisting Yacht Clubs; event sponsors and their directors, officers, members, servants or agents. "Claim" means and includes any action, proceeding, claim, demand, damage or expense however arising including but not limited to negligence but does not include a claim in respect of any action, suit etc made by any person entitled to compensation under a relevant Club insurance policy or under any right expressly conferred by the Club constitution. "Event" means and includes the iSail Lidgett Trophy and Junior Training Weekend.

If accepted I will be permitted to participate in the Event subject to my complying with the terms and conditions of the Event, this declaration and any reasonable direction issued by the Event organisers or their representatives.

The Event rules & this declaration comprise a contract between me and the Club and are necessary and reasonable to promote and conduct the Event. I also agree to abide by the rules and policies of Yachting Australia (copies of which are available from Yachting Australia), and be subject to the jurisdiction of Yachting Australia in relation to the application and enforcement of such rules and policies.

Warning: Participation in the Event can be inherently dangerous. I acknowledge that I am exposed to certain risks during my participation in the Event including, but not limited to, physical exertion and injury, bodily contact, falls, equipment failure and unpredictable weather conditions. I acknowledge that accidents can and often do happen which may result in me being injured or even killed, or my property being damaged. I have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

### WARNING UNDER THE FAIR TRADING ACT 1999

Under the provisions of the Fair Trading Act 1999 several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are:

- rendered with due care and skill; and
- as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
- reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier.

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

For the purposes of this clause 5, "the Supplier" shall mean and include the Club.

Exclusion of Implied Terms: I acknowledge that where I am a consumer of recreational services, as defined by any relevant law, certain terms and rights usually implied into a contract for the supply of goods or services may be excluded. I acknowledge that these implied terms and rights and any liability of the Club flowing from them, are expressly excluded to the extent possible by law, by this Event application declaration. To the extent of any liability arising, the liability of the Club will, at its discretion be limited to the resupply of the services or payment of the cost of having the services supplied again.

Release and Indemnity: In consideration of the Club accepting my application for entry to the Event I, to the full extent permitted by law:

- (a) release and will release the Club from all Claims that I may have or may have had but for this release arising from or in connection with my participation in the Event; and
- (b) indemnify and will keep indemnified the Club in respect of any Claim by any person including but not only another participant in the Event arising as a result of or in connection with my participation in the Event.

Fitness to Participate: I declare that I am and must continue to be medically and physically fit and able to participate in the Event. I will immediately notify the Club in writing of any change to my fitness and ability to participate. I understand and accept that the Club will continue to rely upon this declaration as evidence of my fitness and ability to participate.

Consent to medical treatment: If required, the Club will arrange medical or hospital treatment (incl ambulance transportation) for me. I authorise such actions being taken by the Club where my further consent cannot be obtained & agree to meet all costs associated with such action.

Privacy: I understand that the information I have provided is necessary for the conduct of the Event and for the Objects of the Club. I acknowledge and agree that the information will only be used by the Club to facilitate the conduct of the Event and other events conducted by the Club including the Event in future years. I understand that I will be able to access my information through the Club. If the information is not provided my Event entry application may be rejected.

Copyright and right to use image: I acknowledge and consent to photographs being taken of me during my participation in the Event and authorise the Club to use such photographs for promotional or other purposes without my further consent being obtained. Further, I consent to the Club using my name, image, likeness and also my performance in the Event, at any time, to promote the Event or Club activities by any form of media.

Severance: If any provision of this declaration is invalid or unenforceable in any jurisdiction, the phrase or clause is to be read down for the purpose of that jurisdiction, if possible, so as to be valid and enforceable. If the phrase or clause cannot be so read down it will be severed to the extent of the invalidity or unenforceability. Such severance does not affect the remaining provisions of this membership declaration or affect the validity or enforceability of it in any other jurisdiction.
